O R D E R

The Petitioner Sri Kirtikamal Bora is present. The public authority is represented by Smt. Varshaty Das, SPIO & Deputy Commissioner of Taxes , Zone B, Guwahati.

The SPIO has submitted a written statement dated 5.3.2020 enclosing a copy of letter dated 11.6.2019 from Addl. Commissioner of Taxes addressed to the petitioner Sri Kirtikamal Bora. As mentioned in the enclosed letter, it has been clearly stated that there is no person namely Dr. Moushumi Das working as Superintendent of Taxes, Assam in the Commissionerate . However, certain informations concerning Dr. Moushumi Das, Inspector of Taxes have already been furnished to the petitioner vide letter dated 17.6.2019. The petitioner also received the same on 24.6.2019.

The petitioner, in course of hearing today, informed that he has received informations in respect of points no.1, 2 and 3 of his RTI petition dated 9.5.2019 and rest in respect of points no.4 and 5 are yet to receive. The SPIO in her written statement stated that the informations sought for were already furnished to him vide letter No.RTI-58/2014/392 dated 11.6.2019 by registered post.

The petitioner orally informed the Commission that he has not received any letter reportedly sent by post. He also informed the Commission that he received the intimation of today's hearing through whatsapp. The petitioner informed that since he has not received the copy of today's hearing notice, he has come without any preparation. Since there is an inordinate delay in this particular case, i.e. more than 11 days to deliver the letter, as orally stated by the petitioner, the Registry of this Commission is **directed to inform the petitioner telephonically, in future, to collect the letter from the Commission so that the time of SPIO and the Commission is not wasted.**

In view of the above, the instant second appeal petition dated 17.7.2019 read with RTI petition dated 9.5.2019 is disposed off.
