**O R D E R**  
15.6.2020

1. The petitioner Sri Sultan Ashfique Ahmed is present. The Assistant Inspector General of Police (A) & PIO has submitted a written statement dated 11.6.2020 stating that he had transferred the RTI petition dated 10.4.2019 to the Deputy Commissioner of Police (Admn.) & SPIO of the Office of the Commissioner of Police, Guwahati vide letter dated 30.7.2019 and requested the deemed PIO to attend today's hearing with relevant records. Sri Ponjit Dowarah, ADCP (A), the deemed PIO is present accompanied by Sri Sujit Kr. Deb, ASI of Police. The ASPIO & Addl. Deputy Commissioner of Police (Admn) has submitted a written statement dated 15.6.2020 stating that on receipt of the RTI application a parawise reply was sought from the OC, Dispur PS. On receipt of the reply dated 7.11.2019 from Dispur PS, the same was forwarded to the petitioner vide Office Memo No ECP/RTI/688-19/243 dated 20.11.2019. The written statement is entered into the case records. The information regarding blowing of siren has been given to the petitioner. The petitioner said that he is not satisfied with the information and he has brought the motive and background of blowing the siren at mid night and consequent disturbances.
2. Since the Commission is concerned about giving or not giving the information and not about the motive or background of blowing siren and since the information has already been furnished to the petitioner, the second appeal petition dated 21.10.2019 is disposed of.
