1. The Appellant Sri Joydeb Das is present. The public authority i.e. the SPIO of the Office of Directorate of Agriculture is represented by Dr. N. Roy, SPIO of Directorate of Agriculture accompanied by Sri Prafulla Mahanta, Nodal Officer, BGREI & NFSM and Sri J.H. Choudhury, Nodal Officer & JDA of RKVY.
2. The SPIO & DDA (Seeds) of Directorate of Agriculture has submitted a written statement dated 4.8.2020 which is entered into the case records. The SPIO of Directorate of Agriculture has not given any logical answer except mentioning that he has informed the Director of Agriculture over Whatsapp.
3. The Commission observes that it is the duty of the SPIO of Directorate of Agriculture to collect the information and let this Commission informed about this. The SPIO of Directorate of Agriculture has once again given a chance to furnish the information sought for by the petitioner to avoid the penalty under section 20(1) of the RTI Act, 2005.
