**O R D E R**  
**18-08-2020**

1. The petitioner Sri Kabindra Nath is present. The public authority is represented by Sri Hitesh Sarma Medhi, AEE & SPIO of GMDA,Ghy.
2. The SPIO stated orally that the NOC of the building has been furnished to the petitioner. The SPIO intimates that this building is a 3<sup>rd</sup> party information and he has corresponded with the builder and waiting for his reply.
3. As per Section 11 of RTI Act 2005, the 3<sup>rd</sup> party information is to be obtained within stipulated time and particularly if the information is not marked confidential, the same can be provided without correspondence with the 3<sup>rd</sup> party. Besides the information in public interest can be provided as per the provisions of RTI Act 2005.
4. Since the SPIO has already made correspondence with the 3<sup>rd</sup> party, the Commission directs the SPIO to obtain the information within reasonable time.
5. The Commission directs the SPIO to furnish the information to the petitioner within stipulated time after following due procedure.
6. In view of the above direction, the instant 2<sup>nd</sup> appeal petition dated 10.12.2019 is disposed off.
