- 1. The petitioner Shri Rainul Hussain Choudhury is present.
- 2. The Public Authority is represented by Prakritish Baruah, SPIO and Deputy Secy. Of Secretariat Administration Dept, accompanied by Sri Bidyut Bora, Junior Administrative Assistant of Secretariat Administration Dept.
- 3. The SPIO vide letter dated 7.9.2019 intimated to the petitioner that the information pertaining to question no. 1 would take 6 months. The SPIO Sri Prakritish Barua present in today's hearing informed orally that he has recently been posted in the SAD therefore he is not equipped with the necessary information to be furnished. He also informed the Commission that he would be able to furnish the sought for information within 1 months time.
- 4. Since the earlier 6 months time for furnishing the information is already over, and since the former SPIO has been transferred out and the present SPIO has recently taken over who has assured the Commission that he will be able to furnish the sought for information within 1 month. The Commission directs the SPIO to furnish the information to the petitioner directly within 1 month. The petitioner is advised to personally contact the SPIO accordingly.

In view of the above direction, the instant 2nd appeal petition dated 25.11.2019 is disposed off.
