1. The petitioner Sri Narendra Nath Sarma is absent without any intimation.
2. The Public Authority is represented by Dr. Rajiv Kumar Jha, SPIO & Deputy Director of Elementary Education accompanied by Sri Rajib Lochan Baruah, Deemed PIO & Asstt.
