O R D E R 9.10.2020

- The petitioner Sri Sanjib Tamuli is present. The public authority i.e. the SPIO of 1. Office of the Dhemaji Dev. Block is absent. However the CEO & PD DRDA, Dhemaji has authorized Sri Sasanka Kashyap, Block Project Manager & PIO, Dhemaji BMMU Dhemaji, ASRLM to appear in today's hearing. The Block Project Manager has submitted a written statement dated 7.10.2020 which is entered into the case records. He has mentioned in the written statement that the documents pertaining to RTI petition are in the public domain of NRLM website. Further the documents relating to as many as sixteen number of information in RTI petition sought by the petitioner Sri Sanjib Tamuli have been furnished to him on 14.8.2019 and he has received the same with acknowledgment.
- The petitioner stated orally that some of bank statements are further sought by him. 2. The Commission viewed his request as vague and unjust when he himself has acknowledged that he has received all documents. Filing of second appeal petition is unwarranted.
- 3. When the petitioner has specifically signed that he has received all the documents after that filing of a second appeal petition is not only wasting the time of the Commission as well as the public authority but also an act of mischief and misuse of RTI Act 2005 and harassment of the SPIO by making him present at the hearing, by travelling about 1200 km both ways and remaining absent from office for about three days.
- 4. The second appeal petition dated 26.11.2019 is disposed off.
