**O R D E R**  
13.10.2020

1. The Appellant Sri Joydeb Das is present. The public authority i.e. the SPIO of the Office of the Directorate of Agriculture Sri Bijoy Ch. Sarma. The SPIO of the Office of the Directorate of Agriculture has submitted a written statement dated 12.10.2020 which is entered into the case records.
2. From perusal of the written statement, it is seen that RTI petition remained pending without any action from 4.12.2019 to 17.3.2020, Whereas Section 7(1) the RTI Act states that SPIO should furnish the reply of the RTI petition within 30 days from the receipt of the RTI application. Interestingly, the first appeal petition which was received on 27.1.2020 also remained unattended in violation of provision of Section 19(6) of the RTI Act, 2005.
3. Only on 18.3.2020 the RTI petition was forwarded to the legal cell. From 18.3.2020 to 12.10.2020 no action has been taken on the RTI application. As intimated by the present SPIO Sri Bijoy Ch. Sarma, SPIO post was vacant and work was under disposal of the First Appellate Authority i.e. the Director of Agriculture and after that two SPIOs are already transferred and the present SPIO joined recently.
4. In light of the above, the Commission orders the First Appellate Authority and the Director of Agriculture to file written affidavit giving the reason of delay in attending to RTI petition by SPIO or First Appellate Authority; and departmental actions taken if any for such violation of RTI Act.
