**O R D E R**  
22.07.2020

The appellant is absent without step.

Sri Bijoy Kr. Sarma, Assistant Engineer and SPIO, Pakhimoria Development Block is present.

The SPIO has submitted a written statement vide letter no. PDB/RTI/50/2017-18/3113 dated 17.07.2020. The grievance of the appellant is that he submitted a RTI petition to the SPIO of Pakhimoria Development Block, Nagaon seeking certain informations. For non-receipt of the informations, he submitted a First Appeal to the BDO and the First Appellate Authority of Pakhimoria Dev. Block. His contention for Second Appeal is that the FAA did not hear the First Appeal.

In the written statement of the SPIO, it is informed that the RTI application of Sri Durgeswar Das dated 05.10.2017 was received on the same date and sought for informations were furnished to the applicant on 17.11.2017 by Post vide letter no. PDB/RTI/50/2017-18 dated 06.11.2017. The First Appeal petition of the appellant dated 14.11.2017 was received on 27.11.2017 and the date of hearing for First Appeal was fixed on 22.12.2017 where the appellant did not appear. Further, the SPIO of Pakhimoria Dev. Block received another letter from Sri Durgeswar Das on 08.03.2018 seeking for the same information. Accordingly, the informations were forwarded to the applicant by Post on 23.03.2018 vide letter no. PDB/RTI/50/2017-18 dated 21.03.2018. It is further informed that sought for informations are also available in public domain in the website [www.mgnrega.nic.in](http://www.mgnrega.nic.in).

From the written statement of the SPIO, it is seen that the sought for informations had been forwarded to the applicant twice. Moreover, in respect of allegations of the appellant that his First Appeal was not heard, it is seen from the records produced by the SPIO that hearing for the First Appeal was fixed on 22.12.2017 in which the appellant is stated to be not present.

Since the informations have already been forwarded to the appellant, and the First Appeal was proposed for hearing by the FAA, as such the allegations of the appellant is not tenable.

**The Second Appeal is disposed of accordingly.**
