27-10-2020

- The petitioner Ali Hussain is present and he states that in response to his RTI petition dated 27.1.2020 he has not received any reply and he further filed his 1<sup>st</sup> appeal in March 2020 and he has not received any reply even from 1<sup>st</sup> Appellate Authority and accordingly he filed 2<sup>nd</sup> appeal on 8.7.2020.
- Accordingly, hearing was fixed today i.e., 27.10.2020. In response to letter from the Commission the Inspector of Schools, DDC, Dhubri vide his letter dated 21.10.2020 intimated that the RTI petition though received on 29.1.2020 was transferred to B.D.O. Jamadarhat Dev. Block on 3.1.2020. He further states that he has not received 1<sup>st</sup> Appeal petition.
- 3. The Public Authority to be represented by SPIO of the Office of Inspector of Schools, DDC, Dhubri is absent.
- 4. On perusal of the letter of Inspector of Schools, Dhubri, it is seen that the petition of Ali Hussain was received on 29.1.2020 and was surprisingly transferred to B.D.O. Jamadarhat Dev. Block on 3.1.2020 i.e., 26 days prior to receipt of the application, The Commission is unable to understand how this is possible.
- 5. Therefore, the Commission orders the Deemed SPIO i.e., B.D.O. Jamadarhat Dev. Block and the Inspector of Schools, DDC, Dhubri to personally appear at the next hearing with respective written statement.
- 6. Fix 27.11.2020 at 11:30 A.M. as the next date of hearing. Issue (by name) to notices to both the parties accordingly.
