**O R D E R**  
**12-10-2020**

1. The petitioner Shri Kritikamal Bora is present.
2. The Public Authority is represented by SPIO of the Director of Assam Institute of Management.
3. The petitioner vide his petition no. HA/0360/1/19 has sought information on following 5 questions:-
  - (i) Details of written test advertisement and department on filling of various post by Assam Institute of Management from 1.1.2000 to 7.1.2019.
  - (ii) Approval of Assam government on allotment of expense and filling of those posts.
  - (iii) Utilization Certificate, Bank Statement, Annual Audit Report, Cash Book etc of the above expenditure.
  - (iv) Examination wise expenditure on question paper, OMR sheet etc for the above post.
  - (v) Details of vehicles used in Assam Institute of Management from 1.1.2000 to 7.1.2019.
4. The SPIO in the written statement dated 12.10.2020 certain information sought by the applicant pertaining to conduct of examination which is confidential in nature and as such come under exemption vide Section 8 of RTI Act. They have also quoted the order of Central Information Commission as follows:
  - Hon'ble Central Information Commission in its order dated 22.8.2014 passed in CIC/DS/A/2013/001734SA (Sh. Sudhir Kumar Vs. Dte. Of Education, GNCTD) has deprecated such attitude of 'harassing & repeated questions' and misuse of RTI Act with strong words.
5. The SPIO in the written statement as Annexure-2 letter no. dated 7.2.2019 wherein it is mentioned that information to question no. 1 is already given and the petitioner was asked to inspect the documents as they are voluminous in response to question no. 3.
6. On question no. 2, the SPIO has intimated to the petitioner to deposit Rs 104/- bearing the cost of photocopies to collect the documents.
7. However, the 2<sup>nd</sup> appeal filed by the petitioner has mentioned that he has not got any reply from the SPIO.
8. Since the petitioner has lied and submitted a false appeal at the Commission. The Commission decided not to entertain 2<sup>nd</sup> appeal at the hearing stage.
