<u>O R D E R</u> 22-10-2020

- 1. The petitioner Sri Gunjan Pratim Dutta is present.
- 2. The Public Authority to be represented by SPIO of Elementary Education Department is absent. The SPIO has submitted a written statement dated 21.10.2020 which is taken into records. In the written statement, she has mentioned that the department has furnished reply to question no. 1 directly to the petitioner vide letter no. EAA/RTI/2/2019/6 dated 25.6.2019. In the letter she also mentioned that District Elementary Education Tinsukia is directed to furnish reply to question no. 2, 3 and 4. However, she has not submitted any postal receipt in support of dispatch of the information as petitioner says that he has not received the said letter.
- 3. Further as petitioner has not received this letter obviously he is not aware that the District Elementary Officer will furnish the information to question no. 2,3 and 4 of his query.
- 4. As per Section 6(3) of RTI Act, 2005 whenever the petition is redirected to another PIO it is equal responsibility of the SPIO to see that the appellant gets the information.
- 5. As per Commission letter dated 18.8.2020, it has been clearly mentioned that Deemed PIO U/S 5(4) and 5(5) of RTI Act 2005 is equally responsible for non furnishing or delay in furnishing the information beyond the stipulated period.
- 6. Since the petition is transferred to another PIO it is the responsibility of the SPIO to intimate to the DPIO to attend the hearing.
- 7. Fix 16.11.2020 at 12:00 P.M as the next date of hearing. Issue notices to both SPIO and Deemed PIO to attend the hearing with respective written statement.
