**O R D E R**

24.9.2020

1. The petitioner Sri Durgeswar Das is absent without step. There are as many as five cases for hearing today where Sri Durgeswar Das is the appellant in all these cases. He seems to have lost interest on his applications as informations are stated to have already been furnished.

2. The SPIO of Pakhimoiria Dev. Block is present and submits one written statement bearing No. PDB/RTI/50/2017-18/3147 dated 22.9.2020 whereby it is informed that the sought for informations of RTI petition dated 5.10.2017 was furnished to the appellant Sri Durgeswar Das by post vide letter No PDB/RTI/50/2017-18 dated 6.11.2017. But he received one appeal petition against the RTI petition dated 5.10.2017 on 14.11.2017 and hearing for the same was fixed on 22.12.2017 where the appellant did not turn up in time of hearing. Further, the SPIO of Pakhimoiria Dev. Block received another letter on the same subject on 8.3.2018 from the same applicant Sri Durgeswar Das. The information sought for by this letter also had been furnished to the applicant vide letter No. PDB/RTI/50/2017-18 dated 23.3.2018. It is also further submitted through written statement that these informations are also available in the departmental website [www.mgnrega.nic.in](http://www.mgnrega.nic.in).

3. From the written statement submitted by the SPIO of Pakhimoria Dev. Block, it is seen that the informations sought by the applicant had been furnished twice & same are also available in the departmental website in public domain.

4. In view of the above, the second appeal petition dated 30.1.2018 is disposed of.
