The appellant, Sri Harinarayan Pathak is present.

Smti. Geetanjali Das Saikia, Joint Secretary and SPIO, Legislative Department, Government of Assam is present and submitted one written statement bearing no. LGL.99/2006/463 dated 28.10.2020. Smti. Pranita Boro, Under Secretary & SPIO, Industries & Commerce Department is also present.

The appellant submits orally that although the Legislative Department has not furnished copy of the Assam Gazette Notification in respect of notification no. LGL.142/91/122 dated 14.02.1991 regarding Assam Industrial Infrastructure Development Corporation, 1990 for non-payment of cost of photocopying, yet he received the same from another Department and as such, he is satisfied for the query number 1 of his application. The SPIO of Legislative Department informs that rules are framed by the Administrative Department only and in case of Assam Industrial Infrastructure Development Corporation, rules are prepared by Industries & Commerce Department only. As such, the RTI application was transferred to that Department of furnishing of sought for informations. The appellant submits that he is satisfied with the actions taken by the Legislative Department.

The SPIO of Industries & Commerce Department submits orally that the sought for informations had already been furnished to the appellant through messenger. However, she informs that copies of the informations are available with her and she desires to hand over the same to the appellant. The appellant also desires to accept the informations by hand. As such, photocopies of the informations has been handed over to the appellant by the SPIO in the course of the hearing.

In view of the above, the Second Appeal is disposed of. However, the appellant is at liberty to move this Commission, if the informations furnished are not complete.
