ORDER 25.09.2020

Sri Madhu Sudan Nath, ACS, Addl. Director and SPIO, Directorate of Social Welfare, Assam is present along with Md. Khasnur Ali, Senior Assistant.

The petitioner, Sri Harinarayan Pathak is present.

The SPIO submitted one written statement. The appellant submitted one RTI petition dated 12.10.2018 to the SPIO of Directorate of Social Welfare, Assam. In response to the said RTI petition the deputy Director and SPIO of Directorate of Social Welfare, Assam furnished the informations vide their letter no. DSW (G)293/2016/29 dated 31.12.2018. But the applicant was not satisfied with the informations so provided with claiming it to be incomplete. He then submitted First Appeal petition dated 13.12.2018 before the First Appealate Authority of Directorate of Social Welfare, Assam. Hearing for the First Appeal was fixed on 25.03.2019 and notices were served accordingly. In the Second Appeal petition dated 12.07.2019 the appellant informs that no hearing for the First Appeal was conducted on 25.03.2019 as the Director was not present. Instead there was an informal discussion held between the petitioner and the officials of the Directorate. It is also submitted that after the discussion no further informations was furnished to the appellant. As such, he preferred Second Appeal before the Commission.

Heard the appellant. He informs that he had received informations as sought for excepting file notings. He requests to pass necessary order to the SPIO to furnish the remaining informations.

Heard the SPIO of Directorate of Social Welfare, Assam. He submits that the required informations will be furnished as ordered. However, he seeks some time for the same as he has joined the office recently.

In view of the above, it is hereby ordered that remaining informations sought for by the appellant will be furnished by the SPIO within 15 days from the date of receipt of this order without cost.

The Second Appeal is disposed of with the above direction.
