Sri Hitesh Sarma Medhi, Assistant Executive Engineer and SPIO of GMDA is present.

The SPIO of GMDA submits one written statement vide letter no. GMDA/RTI/2019/55/13 dated 18.11.2020. It is informed that sought for informations had been furnished to the appellant vide letter no. GMDA/RTI/2019/55/12 dated 10.11.2020. The representative of the appellant submits orally that the PIO of GMDA has furnished informations but in respect of certain points the authority refrained from furnishing informations stating to be third party information.
