O R D E R

Smti. Lakshmi Das, Supervisor is present as deputed by the CDPO, Sipajhar ICDS Project, Darrang.

The Petitioner, Sri Pabitra Deka is present.

Perused the case record. The Appellant had submitted through his Second Appeal dated 18.06.2019 that he had not received any information which he had sought through his RTI Application dated 25.01.2019. He had sought information on (i) the birth certificates and (ii) the names and addresses of the guardians in respect of children based on the monthly report submitted by the supervisor Smti. Gitanjali Deka in respect of the centres under their jurisdiction for the month of March, 2018.

Heard the CDPO's depute and perused the Written Statement. The information was furnished to the Appellant through a letter dated 30.07.2019. A copy thereof has been enclosed with the Written Statement. Through the letter the Appellant had been informed that there was no instruction to collect and maintain birth certificates in respect of children and that the Anganwadi centres take note of the date of birth of children as recorded in the Health Department Card issued in respect of mother and child. The Appellant accepted the plea of the birth certificates not being available with the CDPO/the Anganwadi centres. However, he contended that the names and addresses of the guardians in respect of children were maintained in the centres and therefore should be supplied to him. The CDPO's depute agreed that this information was indeed maintained.

Considering the submissions as above, **the Commission hereby orders that the SPIO/CDPO shall furnish the information on point number 2 of the RTI Application namely names and addresses of the guardians in respect of each children registered in the centres specified by the Appellant, free of cost, within 15 days of receipt of this order.**

With the above direction, the Second Appeal is hereby disposed of.
