The SPIO submits through the letter and also by an affidavit dated 05.11.2020 stating that the delay in furnishing the informations to the appellant was mainly because of the fact that the relevant letters, orders were not brought to his notice by office staff in due time. Further, due to pressing work of preparation of NRC and election related work amounts to further delay for which he begs apology and assured that he will took all necessary steps to furnish informations against RTI petitions in future. It is also mentioned that the informatons had been received by the appellant Sri Nurul Haque to his satisfaction and enclosed one letter of Sri Nurul Haque stating that that he has received all desired informations and requests the Commission to exempt him from appearing from today's hearing.

In view of the submissions, **the SPIO, o/o the BEEO, Ramkrishna Nagar and the appellant as stated above, the 2nd Appeal is disposed of. However, the SPIO and the BEEO, Ramkrishna Nagar is directed to instruct his staff to deal matters with seriousness relating to RTI Act, 2005 and application to be brought to his notice forthwith.**
