**O R D E R**

13.11.2020

The appellant is absent for consecutive two days of hearing. The SPIO and Marriage Officer of Bhangabazar, Karimganj is absent but has submitted one letter bearing no. 250 dated 14.10.2020. It is stated that he has sent the letter to the Commission vide letter no. 228 dated 29.09.2020 stating that no marriage between Mashuk Ahmed Choudhury and Saleha Begum was registered in his office during the period from 01.01.2019 to 30.08.2019. The Commission has not received the letter yet.

Seen the case record. The contention of the second appeal petition is that the appellant Md. Abdul Noor submitted one RTI petition dated 05.11.2019 seeking certain informations. The SPIO, o/o the Marriage Officer/Sub-Registrar, Bhangabazar did not furnish any information within the stipulated period under the RTI Act, 2005. Then the appellant submitted first appeal dated 09.12.2019 before the Deputy Commissioner, Karimganj but no action was taken by the 1<sup>st</sup> Appellate Authority also. Being aggrieved, he submitted second appeal before the Commission which was received on 11.02.2020.

Seen the letter of Marriage Officer/Sub-Registrar, Bhangabazar bearing no. 250 dated 14.10.2020 wherein it is informed that no marriage was registered between Mashuk Ahmed Choudhury and Saleha Begum in his office during the period from 01.01.2019 to 30.08.2019. Since the marriage was not registered hence sought for informations are obviously not available in the office. Hence, the ground of furnishing informations also does not arise. A copy of the letter no. 250 dated 14.10.2020 is seen to have been forwarded to Abdul Noor.

In view of the above, **the 2<sup>nd</sup> Appeal is disposed of with no order.**
