**O R D E R**  
13.10.2020

The appellant Sri Nayanmani Das is present.

Dr. Pankaj Kr. Roy, Principal i/c, Uttar Kampith Mahavidyalaya, Nalbari is present. He informs that notice of the Commission no. SIC/BGS.3/2020/17 dated 22.06.2020 has not been received by him. However, he has received the notice of the Commission dated 08.09.2020. He submits orally that for non-receipt of first hearing notice he has not come prepared with any written statement. Further, he submits that informations sought for by Sri Nayanmoni Das has already been furnished vide letter no. UKM/RTI/2019/256 dated 26.09.2019. On query the appellant submits that he has received the said letter from the Principal of Uttar Kampith Mahavidyalaya, Jagara but he is not satisfied as instead of furnishing informations he was informed that the sought for informations fall under section 8.1 (j) of the RTI Act, 2005 and as such, the documents could not be furnished.

The Principal, Uttar Kampith Mahavidyalaya submits orally that he has not notified the names and designations of SPIO as well as the First Appellate Authority of his college. He is directed to notify it immediately under proper section of RTI Act, 2005. He will further submit a written statement in the next date of hearing along with documentary proofs for action already taken from his end. The appellant is directed to establish what sort of greater interest lies for the divulgence of personal documents like marksheets/professional qualification of M.Phil etc. of Sri Sanjay Sarma, Assistant professor of Uttar Kampith Mahavidyalaya. However, it is admitted that the appointment letter of any college teacher should not be considered as a personal document.
