O R D E R 17-11-2020

- 1. The petitioner Razibul Islam Mondal is present.
- 2. The Public Authority to be represented by SPIO of the Office of Gotabari Khopatia G.P. is absent without any intimation.
- 3. The petitioner filed his RTI petition dated 16.10.2019 asking for information about the works done under MGNREGA in Gotabari Khopatia G.P.
- 4. On failure to furnish the information within stipulated time, the petitioner submitted 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority i.e., Office of the Block Development Officer on 18.11.2019.
- 5. The 1<sup>st</sup> Appellate Authority in its order dated 26.11.2019 has directed the G.P Secretary of Gotabari Khopatia Sri Foyzal Hoque Sarkar and SPIO of Fekamari Dev. Block Sri Iqbal Rasul to provide the information to the petitioner within 10 days from the date of issue of the letter.
- 6. However, the G.P Secretary failed to give any information to the petitioner and also failed to appear at the hearing. He has also not filed any written statement in connection with submission of the information.
- 7. In light of the above, The Commission directs the SPIO to submit a written statement as to why penalty should not be imposed on him as per provision of Section 20(1) of the RTI Act for not furnishing the information during the stipulated time period.
- 8. Fix 18.12.2020 at 11:45 A.M as the next date of hearing.
