**O R D E R**  
**3-12-2020**

1. The petitioner Sri Aswini Bezbaruah is present.
2. The Public Authority is represented by Sri Gunjanan W. Shyam, ASPIO of the Office of Assam Seeds Corporation Ltd.
3. The petitioner filed his 2<sup>nd</sup> appeal petition on 28.2.2020 stating that he has not got any reply from SPIO, Directorate of Agriculture, Khanapara of his RTI petition dated 29.10.2019. However the Commission finds that the petitioner has put some questions i.e., No. IV, IX and X which is not in consonant with the provision of RTI Act, 2005.
4. The ASPIO Sri Gunjanan W. Shyam has stated that the reply to the RTI petition was sent on 10.2.2020 and he has no record of it, as it was sent through ordinary post.  
Hence, the Commission advises the ASPIO to send the reply through speed post in future which is recorded and traceable.
5. The ASPIO further stated that today he is furnishing copy of the reply to the petitioner and most of the questions asked by the petitioner are uploaded in their website.
6. In light of it, the instant 2<sup>nd</sup> appeal petition dated 28.2.2020 is disposed off.
