- 1. The petitioner Sri Abdul Jalil Akanda is absent. However, he has sent an email dated 19.11.2020 wherein it is mentioned that he is suffering from fever.
- 2. The Public Authority is represented by Sri Rubul Pathak, Assistant Conservator of Forest, Office of the D.F.O. Sonitpur West Division Tezpur. The SPIO of Office of D.F.O.,West Sonitpur has submitted a written statement which is taken into records. In the written statement it is mentioned that petitioner Sri Abdul Jalil Akanda from Nagaon has submitted a RTI petition on 11.7.2018 and the reply to same has been provided vide DFO, Sonitpur, West Division, Tezpur letter no. FSWT/B/RTI Act.2005/2018/4385 dated 19.7.2018 and letter no. FSWT/B/RTI Act.2005/2018/4385 dated 19.7.2018.
- 3. In response to 1st appeal petition dated 27.8.2018, the SPIO of the Office of D.F.O., West Sonitpur again furnished the information to the petitioner vide letter no. FSWT/B/RTI Act,2005/2018/5294 dated 07/09/2018.
- 4. It is seen that the petitioner 2nd appeal 10.10.2018 where he states that he did not receive any information.
- 5. The Commission therefore observes that the petitioner has been duly provided the information from D.F.O. Sonitpur, West Division, <u>but he has not intimated the Commission about the same thereby wasting the time and resources of this Commission.</u>
- 6. In light of the above, the instant 2nd appeal petition dated 10.10.2018 is disposed off.
