## O R D E R 21-12-2020

1. The petitioner Sri Saman Ali Sk is absent without any intimation.

- The Public Authority is represented by Sri Pranju Chakrapani, SPIO & SDE(I/C), Bilasipara EST., APDCL accompanied by Sri Ashim Thakuria, AGM (REM), Dhubri District.
- 3. The petitioner in his letter dated 10/11/2020 stated that point nos.1,2 and 3 of the RTI application are already furnished to him but information regarding point no.4 and 5 were not given.
- 4. The SDE(I/C) stated that information is available with AGM, Rural Electrical Division.
- 5. The AGM (REM), Dhubri has orally stated that information relating to question no.5 (b, c and d) are available in his office which will be given to SDE (I/C). However, information relating to point no. 5 (h and i) are not available with them.
- 6. In light of the above, the Commission directs the AGM, Rural Electrical Division and Sub Divisional Engineer cum SPIO to furnish the available information to the petitioner.
- 7. The instant 2<sup>nd</sup> appeal petition dated 24/9/2020 is disposed off.
