1. The petitioner Sri Jiten Payeng is present. The petitioner vide his RTI petition dated 5/5/2020 before SPIO of the Office of D.C.Dhemaji asking for weight and cash memo of rice bag distributed to following Cooperative Societies:-

Dhemaji Samabhai Samiti, Moridhol Samabhai Samiti, Ming Mang Samabhai Samiti, Sisibor Gaon Samabhai Samiti, Kangkan Samabhai Samiti, Gogamukh Samabhai Samiti, Paschim Machkhuwa Samabhai Samiti, Bordoloni Samabhai Samiti, Kolajaan Samabhai Samiti and Muktiyaar Samabhai Samiti.

 2^{nd} question relates to the distribution of extra rice during lockdown period and the weight of the rice bags and cash memo.

- 2. On perusal of the case it is found that Assistant Director of Food, Civil Supplies & Consumer Affairs has forwarded a letter vide no.DIS.12/2020/3 dated 30/5/2020 to all the 10 cooperative societies to provide the information directly to the petitioner within stipulated time period.
- 3. In today's hearing no representative of Asstt. Director of Food, Civil Supplies & Consumer Affairs, Dhemaji was present.
- 4. The petitioner has stated in his 2nd appeal that only Kolajaan Samabhai Samiti and Moridhol Samabhai Samiti have furnished the information to the petitioner, but others are yet to give the relevant information.
- 5. Though the petitioner has stated in his 2nd appeal petition about getting replies from only Kolajaan Samabhai Samiti and Moridhol Samabhai Samiti but on perusal it is seen that Muktiyaar Samabhai Samiti has already furnished him the information, but the petitioner has not mentioned about it in his 2nd appeal which is suppression of information and misleading the Commission.
- Since the SPIO/Deemed PIO is not present, the Commission fixes 20.1.2021 at 11:30 A.M as the next date of hearing and directs the SPIO/Deemed PIO to submit written affidavit why no penalty U/S 20(1) of the RTI Act.2005 to be imposed on him.
