O R D E R

8.12.2020

1. The petitioner Sri Harinarayan Pathak is absent. The petitioner Sri Harinarayan Pathak has filed his RTI petition dated 10.2.2020 under Section 6(1) of RTI Act, 2005 seeking information as follows:
 - (i) Copy of each and every Office Letter, Office order, etc. under SIGNATURE of Smti Manjula Saikia Bhuyan IAS (Non SCS 2010), as Managing Director, Assam Industrial Infrastructure Development Corporation (A Govt. of Assam Public Enterprise), issued from AIIDC w.e.f. 5th June, 2018 in terms of Govt. of Assam Notification vide Nos. (a).AAI.15/2017/429 dated 5th June, 2018 and (b) AAI.15/2017/430-A dated 5th June, 2018
 - (ii) Copy of each and every Minutes of the Meeting of the BOARD of DIRECTOR of AIIDC w.e.f. 5th June, 2018 till 10.2.2020 with respective Agenda Notice & Agenda Note.
2. Then the petitioner filed his first appeal petition dated 17.3.2020 and after that he has filed second appeal dated 18.6.2020 before the Commission and accordingly the hearing is fixed today.
3. The public authority i.e. the SPIO of the Office of the Assam Industrial Infrastructure Development Corporation Sri Ritumoni Pachani, GM of AIIDC is present and has submitted a written statement dated 7.12.2020 which is taken into case records. In the written statement he has mentioned that they had returned the application with a request to deposit the application fee in the form of IPO/Money receipt from the cash counter of AIIDC vide letter No AIIDC/1195/2012/111/276 dated 25.2.2020. To this the petitioner replied that he has paid Rs. 10 note and letter of AIIDC has no merit. After this vide letter No. AIIDC/1195/2012/469 dated 23rd March, 2020 the SPIO asked the petitioner to deposit Rs. 5950/- for the cost of voluminous documents as he has asked for. But no reply has been received from the petitioner. The first appeal petition could not be heard due to the Covid situation.
4. Since the petitioner has not deposited any cost till date, the Commission therefore, orders the petitioner to deposit the cost if he desires to receive the information and the SPIO of AIIDC is also directed to furnish the information if the information is not exempted under Section 8 of the RTI Act and if the information is not third party, where the party is unwilling to share under Section 11 of the RTI Act, 2005.

5. With the above directions, the second appeal petition dated 18.6.2020 is disposed off and no further communication to be entertained.
