- 1. The petitioner Shohidul Islam Mollah is absent
- 2. The petitioner vide his RTI application dated 12.9.2019 has sought the following information:
 - (a) Certificate copy of Chatapara Chirakuti Junior Madrassa, Student Register Book w.e.f. 02.01.2019 to 12.9.2019
 - (b) Certificate copy of Chatapara Chirakuti Junior Madrassa, Total Enrollment w.e.f. 02.01.2019 to 12.9.2019
 - (c) Certified copy of Chatapara Chirakuti Junior Madrassa E.V. Attendance Register w.e.f. 02.01.2019 to 12.9.2019
 - (d) Certified copy of Chatapara Chirakuti Junior Madrassa Resolution Book and Approval Management Committee w.e.f. 02.01.2019 to 12.9.2019
 - (e) Certified copy of Chatapara Chirakuti Junior Madrassa E.V. Appointed and Joining Letter w.e.f 02.01.2019 to 12.9.2019
 - (f) Certified copy of Chatapara Chirakuti Junior Madrassa Joint Account passbook Xerox Copy w.e.f. upto date 12.9.2019
 - (g) Certified copy of Chatapara Chirakuti Junior Madrassa Acquidance Register Book w.e.f. 02.01.2019 to 12.9.2019
- On failure to furnish the information within stipulated time, the petitioner filed 1st appeal petition dated 16.10.2019 before the 1st Appellate Authority of the Office of the DMC, SSA, Dhubri.
- 4. On not getting any reply, the petitioner then filed 2nd appeal before the Commission on 25.11.2019. Accordingly a date of hearing was fixed by the Commission on 12.10.2020 at 11.30 AM vide notice no.SIC/DHR.68/2019/8 dated 7.10.2020 to hear the matter. On the date of hearing the DPO(CP), SSA, Dhubri and DPO(ST), SSA, Dhubri were present. The District Mission Coordinator submitted a written statement dated 10.10.2020 stating that the Secretary of Chatapara Chirakuti Junior Madrassa was directed to provide the information sought by the appellant free of cost.
- 5. Accordingly next date of hearing was fixed on 23.11.2020 vide notice No. SIC/DHR.68/2019/22 dated 5.11.2020. On the date of hearing the petitioner is present and the Secretary of Chatapara Chirakuti Junior Madrassa submitted a written statement dated 21.11.2020 stating that the necessary information had

been furnished to the petitioner vide letter dated 15.11.2019 through Registered Post. However, the petitioner orally stated that the Registered Post weighed only 30 gms and contained only letter without any documents. Therefore, the Commission directed the SPIO of the Office of the Secretary Chatapara Chirakuti Junior, Madrassa to personally present on today's hearing.

- 6. However, the SPIO of Office of the Secretary Chatapara Chirakuti Junior Madrassa has neither compiled with the Commission's earlier order dated 23.11.2020 to personally appear before the Commission today at 11:30 A.M nor he made any written submission as to why penalty u/s 20(1) shall not be imposed on him. As such it appears to be a case of non-compliance of the Commission's order by the SPIO of Office of the Secretary Chatapara Chirakuti Junior Madrassa.
- 7. Since the complaint was non enclosure of required documents and the SPIO of the Office of the Chatapara Chirakuti Junior Madrassa could not be heard personally in spite of repeated communications, the Commission decides penalty Rs 10,000/to impose on him а of (Ten Thousand). However, he is given one more chance to explain why the penalty should not be imposed on him. He is therefore directed to file a written affidavit in this regard within 10 days of receipt of this order.
