<u>O R D E R</u> 06.01.2021

- 1. The petitioner Sri Harinarayan Pathak is absent. However, he has sent letter dated 6.1.2021 which is being taken into consideration.
- 2. The SPIO of the Office of the Industries & Commerce Department Smti Pranita Boro and Smti Rami Katharpi, ACS First Appellate Authority & Secretary of Industries & Commerce are present. The SPIO of Industries & Commerce Department has submitted a written statement dated 31.12.2020 which is entered into the case records.
- 3. It is mentioned in the written statement that the requisite information has already been furnished to the petitioner vide Department's letter No. CI.133/2019/12 dated 11.11.2020
- 4. However, the petitioner has mentioned that no specific reply has been given in respect of query No. (1) of his RTI petition dated 28.8.2020, to which the SPIO replies that though the direction was given vide notification dated 20.4.2006 (copy of which is given to the appellant) to the Superintendent of Assam Government Press for Gazattee notification, the department has been not replied whether it is published or not.
- 5. In respect of query No. 3 file notings is furnished though the appellant has mentioned that it is incomplete.
- 6. Regarding the point No. 4, though the appellant has mentioned that complete names of Officials are not given. the SPIO mentioned that the file notings are very old and relates to 2006 and it is not possible to give the complete names from the designation and signatures relating to that period.
- 7. In light of it, the second appeal petition dated 3.12.2020 is disposed off.
