O R D E R 6-1-2021

- 1. The petitioner Shri Joydeb Das is absent. However he has sent an email dated 5/1/2021 wherein he has mentioned that the sought for information is not furnished to him.
- 2. The Public Authority to be represented by SPIO of DC, Kamrup, Amingaon (Disaster Management Branch) is also absent. However the SPIO of DC, Kamrup Amingaon has submitted a written statement dated 5/1/2021 which is taken into records.
- 3. In the written statement it is mentioned that the Office of DC, Kamrup has written a letter vide no.KDM.59/2020/11/2239-40 dated 13/10/2020 to District Agricultural Officer, Kamrup, Ulubari to furnish the list of flood affected farmers of Char Areas, but the same has not been received by them.
- 4. The Commission therefore directs the SPIO/ District Agricultural Officer, Kamrup, /Ulubari to provide the sought for information within 1 month directly to the petitioner.
- 5. In light of the above, the instant 2nd appeal petition dated 19/10/2020 is disposed off.
