## ORDER 05.02.2021

4. The Circle Officer, Dispur Revenue Circle has sent a copy of letter dated 23.12.2020 addressed to the petitioner Smti Anju Chouhan, wherein the information as regards remaining point is provided. However, the representative of the petitioner stated that he has not received any information from the Circle Officer, Dispur Revenue Circle.

The Commission therefore, directs the Registry of this Commission to furnish a 5. copy of letter dated 23.12.2020 to the petitioner.

With the above order, the second appeal petition dated 18.12.2020 is disposed 6. off.
