The appellant Sri Baikuntha Chetia is present.

The SPIO submits one written statement vide letter no. DTA.373/2019-20/881 dated 12.01.2021. The SPIO submits orally that he is constantly searching the record which has been sought for by the appellant and now he is in a position to submit report to the Accountant General (AG) against Nil Bills of the appellant.

The appellant submits orally that he should get the amount payable to him against Nil Bills at an early date since it is more than 10 years that he has retired from service.
