**O R D E R**  
28.12.2020

There are as many as eight cases for hearing today where Sri Durgeswar Das is the appellant. He is absent in all the cases without step. He seems to have lost interest in his appeal/informations.

Smti. Juri Saikia, Block Dev. Officer, Mayong Dev. Block is present. She submits orally that she has joined this office recently and came to know about the RTI petition of Sri Durgeswar Das only after receipt of the hearing notice from the Commission. She also informs that the sought for informations are almost ready for inspection but requires some time as audit from the Accountant General of Assam is going on and will continue up to 10<sup>th</sup> of January, 2021.

Seen the 2<sup>nd</sup> appeal petition dated 19.02.2018. The contention of the appellant is that the BDO did not arrange hearing against his 1<sup>st</sup> appeal petition. He has misled the Commission about submission of 1<sup>st</sup> appeal petition and it is not enclosed with his 2<sup>nd</sup> appeal petition.

It is also observed that the sought for informations are large in numbers as it relate to a period from 2007-2008 to 2015-2016. **The Commission therefore, directs the appellant Sri Durgeswar Das to visit the office of the BDO, Mayong Dev. Block after 15<sup>th</sup> January, 2021 in a mutually agreed date. The SPIO, o/o the BDO, Mayong Dev. Block is directed to issue a letter inviting the appellant for inspection of records/informations and also to take photocopy, if desired. Twenty copies of informations will be given to the appellant, free of cost, and for the rest he will have to pay at the prescribed rate.**

**The 2<sup>nd</sup> appeal dated 19.02.2018 is disposed of.**
