**O R D E R**

23.12.2020

There are as many as eight cases for hearing today where Sri Durgeswar Das is the appellant. He is absent in all the cases without step. He seems to have lost interest in his appeal/informations.

Sri Bijoy Kr. Sarma, Assistant Engineer/SPIO of o/o the BDO, Pakhimoria Dev. Block is present and submitted one written statement vide letter no. PDB/RTI/50/2020-21/20 dated 21.12.2020. It is submitted that the 1<sup>st</sup> Appellate Authority of Pakhimoria Dev. Block arranged hearing for 1<sup>st</sup> appeal petition dated 15.12.2017 of Sri Durgeswar Das fixing date of hearing on 08.03.2018 and notice was served accordingly but the appellant Sri Durgeswar Das did not attend the hearing. Thus, it is observed that the appellant has misled the Commission submitting the 2<sup>nd</sup> appeal petition dated 22.02.2018 with the contention that no action was taken by the FAA against his 1<sup>st</sup> appeal dated 15.12.2017. Further, the sought for informations was furnished to the appellant vide letter no. PDB/RTI/50/2017-18 dated 31.03.2018. Therefore, Sri Durgeswar Das is hereby warned not to mislead the Commission in future unless legal action will be initiated against him.

**The 2<sup>nd</sup> appeal petition dated 22.02.2018 is disposed of.**
