The SPIO, Housefed, Assam vide its letter no. HFG.364/2019-20/Pt.II(A)/41 dated 18.12.2020 informs the Commission that all required documents had been furnished to the appellant through letter no. HFG.364/2019-20/Pt.II(A)/46 dated 18.12.2020. The appellant submits orally that he is in receipt of informations in respect of three queries of his petition dated 20.11.2019.
