The Complainant is absent.

The SPIO, o/o the Principal Secretary, Karbi Anglong Autonomous Council (KAAC), Diphu is absent.

From postal tracking record, it is seen that the notice of hearing has been served duly.

Seen the order of the Commission dated 29.11.2019. The operative part of the order is as follows-

"The Principal Secretary, KAAC, Diphu /1<sup>st</sup> Appellate Authority is hereby directed to appoint a subordinate officer or staff as an State Public Information Officer U/S 19 (8) of the RTI Act, 2005 for his office so that he could discharge the responsibility of FAA himself U/S 19 (1) of the said Act." Although it was ordered more than one year back, no information in respect of appointment of SPIO in KAAC is received by the Commission.

Seen the RTI petition dated 03.10.2018 submitted by Sri Mangal Sing Lekthe. Neither the SPIO nor the public authority of KAAC, Diphu submitted any objection or sought exemption from furnishing of the informations. Therefore, **the Commission orders that the SPIO**, **o/o the KAAC**, **Diphu to furnish the sought for informations to the appellant**, free **of cost**, within 15 (fifteen) days of receipt of this order.

The complaint petition dated 10.05.2019 is disposed of.
