The Deputy Director of Sanskrit Education submits one letter vide no. SE/Misc/EASB/12/2020/279 dated 21.12.2020 whereby it is submitted that he is in receipt of one letter from the Registrar of Kumar Bhaskar Varma Sanskrit & Ancient Studies University, Namati whereby it is informed that the University did not receive any documents except the tabulation sheet containing no names of the candidates prior to 2016 for different examinations conducted by the erstwhile Sanskrit Board. The Deputy Director also submits orally that there was a discussion with the previous members of the Sanskrit Board namely Sri Rajendra Nath Sarma, Sri Ajit Kumar Sarma, Sri Bimal Krishna Bhattacharya.
