Dr. Chittaranjan Pathak, Joint Director of Health Services, o/o the Directorate of Health Services, Assam/SPIO is present and submits one written statement. Dr. Nitul Sarmah, Deputy Director of Medical Education, Assam is also present.

Sri Abhijit Roy as authorized by the appellant is present.

In the letter of the SPIO and Joint Director of Health Services, Assam DHS(MCH) o/o the DHS (FW), Assam bearing no. HSFw/RTI/02/08/1907 dated 21.09.2020, it is informed that the RTI application of Smti. Pinky Roy was forwarded to the Controller of Examinations-cum-Member Secretary o/o the DME, Assam vide letter no. HSFw/RTI/02/08/2492-A dated 09.12.2019 for taking necessary action. On the other hand Dr, Nitul Sarmah, Deputy Director of Medical Education, Assam informs vide letter no. DME/RTI/389/2018/11854 dated 21.09.2020 that his Directorate has not received the transferred RTI application of Smti. Pinky Roy from Directorate of Health Services (FW), Assam. It is also submitted that the informations sought for by the petitioner is related to the Directorate of Health Services, (FW) only.

The Commission therefore directs the SPIO, o/o the Directorate of Health Services, (FW), Assam to ascertain who is the present custodian of the sought for informations and the present custodian i.e. either Directorate of Health Services (FW), Assam, Hengrabari or Directorate of Medical Education, Assam Sixmile will furnish the sought for informations to the appellant as per provision of RTI Act, 2005 if the same are not exempted under section 8 of the said Act.

The 2nd appeal petition dated 23.12.2019 is disposed of.
