The appellant Sri Harinarayan Pathak is present.

The SPIO, o/o the Commissioner of Industries & Commerce, Assam is absent today without any informations. However, one letter from his office bearing no. CI&C(1)82/RTI/2020/147/7921 dated 01.01.2021 is received. It is submitted that the sought for informations had already been furnished to the appellant vide letter no. CI&C(1)82/RTI/2020/134 dated 21.08.2020. On query the appellant Sri Harinarayan Pathak informs that he has received the sought for informations but not satisfied as most of the papers are not legible. Therefore, he can't understand the materials furnished by the SPIO and therefore he request the Commission to direct the SPIO, o/o the Commissioner, Industries & Commerce, Assam to furnish legible copies of the informations. The Commission inspects the copies of the informations received by Sri Harinarayan Pathak and he is of the opinion that most of the documents furnished by the SPIO are illegible. It is therefore ordered that the SPIO, o/o the Commissioner of Industries & Commerce, Assam will furnish legible copies of the informations to the appellant within 7 days from the date of receipt of this order.

With the above, the 2<sup>nd</sup> appeal dated 27.07.2020 is disposed of.
