The appellant Sri Harinarayan Pathak is present.

Sri Razzaquel Hussain, SPIO, Housefed, Assam is present and submits one affidavit dated 20.01.2021 which is entered into the case record. It is informed that as per record available at Housefed, one deed of agreement was registered between M/s Tealand Housing Society and Housefed on 05.06.1997 for transfer of land from Tealand Housing Society to Housefed. Subsequently, one writ petition was filed before the Hon'ble Gauhati High Court by the Assam State Transport Corporation (A.S.T.C.) for the same plot of land and for the same the whole matter got delayed and no sale deed was executed, as such, the question of furnishing of copy of the same does not arise.

The petitioner Sri Harinarayan Pathak sought four nos. of informations from the SPIO of Housefed vide his application dated 20.11.2019. The informations in respect of three queries has already been furnished and the appellant is satisfied with that. The other information cannot be furnished as no sale deed was registered as sought for by the appellant.

The appellant agrees to the point that no sale deed was registered so he may not be given the copy of the same but he wants to get a copy of the affidavit submitted by the SPIO of Housefed today. He is advised to seek a copy of the same in writing to the Registrar of Assam Information Commission.

In view of the above, since three nos. of informations had already been furnished and the fourth informations is not available, as such, the 2^{nd} appeal dated 21.03.2020 is disposed of with no order.
