O R D E R

The appellant is absent without step.

The SPIO, o/o the Merapani GP is also absent without step. However, the case is taken up for hearing as it is a matter of non-compliance of the order of the 1st Appellate Authority by the SPIO of Merapani GP.

Seen the case record. The appellant Md. Tohid Hussain submitted one application dated 18.11.2019 under RTI Act, 2005 before the SPIO and the Secretary, Merapani GP seeking certain informations. The appellant submitted 1st appeal petition dated 09.01.2020 before the BDO, Gomariguri Dev. Block. The BDO arranged hearing for 1st appeal petition and passed order directing the SPIO i.e. Secretary, Merapani GP to furnish the informations within 3 days. Accordingly, the Secretary, Merapani GP furnished the informations relating to IAY and PMAY to the appellant vide letter no. MGP81/RTI/2012-13/2019-20 dated 10.02.2020. Since the FAA i.e. BDO passed order to furnish the sought for informations, it is presumed that the sought for informations are not exempted under section 8 of RTI Act, 2005. **Therefore, the SPIO, Merapani GP is directed to furnish rest of the informations to the appellant within 15 days of receipt of this order, free of cost.**

The 2nd appeal petition dated 18.05.2020 is disposed of.
