It is therefore, **ordered that the BEEO, Dalgaon Sialmari will furnish a copy of the order of the Director of Elementary Education, Government of Assam for release of monthly salary of Sri Suraj Ali, Assistant Teacher of Besimari Girls' ME Madrassa within 15 days from the date of receipt of this order without cost. The appellant will collect copy of the informations from the SPIO, o/o the BEEO, Dalgaon Sialmari Block.**
