1. The petitioner Shri Diganta Das is present.
2. The Public Authority to be represented by SPIO of the Office of Deputy Commissioner, Golaghat is absent.
3. The petitioner vide his RTI petition dated 1/10/2020 has asked for following information:-
 - (a) Information regarding the number of card possess by the agent Sri Manik Saikia from 2014 to 1/10/2020.
 - (b) Information regarding the beneficiaries, computer list, ration unit number etc of the agent Sri Manik Saikia for each year.
 - (c) Information regarding the beneficiaries along with the front page of ration card for photographic evidence in his retail shop.
 - (d) Information against the number of member against each card along with their Voter card/Voter list/Panchayat certificate/ Aadhar card.
 - (e) Month wise data of food items uploaded in record book and quta book.
 - (f) Certified year wise/month wise sale report of the said store.
4. The SPIO of the Directorate of Food, Civil Supplies and Consumer Affairs, Bhangagarh sent the petition to the Office of Deputy Commissioner, Golaghat vide letter no. DS.70/2014/74. Realising that the agent doesn't fall under his jurisdiction, he forwarded it to PIO, D.C. Office Majuli to furnish the information and till date information is not furnished to the petitioner.
5. In light of it, the Commission directs the SPIO, Office of D.C.Majuli to provide the information directly to the petitioner.
6. The case is disposed off.
