<u>O R D E R</u> 16.12.2020

Smti. Sukanya Bora, ACS, Circle Officer and SPIO, Hajo Revenue Circle is present along with Md. Nur Islam, Junior Assistant.

The appellant is represented by his learned Advocate, Sri Dipjyoti Baishya.

Seen the case record. The appellant Sri Soneswar Baishya submitted one application dated 07.07.2018 before the SPIO, o/o the Deputy Commissioner, Kamrup and the same was transferred to the Circle Officer, Hajo Revenue Circle under section 6(3) of the RTI Act, 2005 vide letter no. KPE/RTI/15/2015/Pt./207 dated 12.07.2018. For non-receipt of the informations within the stipulated time the appellant submitted 1st appeal before the 1st Appellate Authority/DC, Kamrup.

Seen the order of DC, Kamrup of appeal case no. 3708/19/255 dated 13.05.2019. The operative part of the order reads as follows-

"Also heard the Circle Officer, Hajo Revenue Circle, and it has been observed that the informations pertaining to the Circle Officer, Hajo Revenue Circle has been furnished vide letter no. HRC/28/2017/4547 dated 04.05.2019 and as such, the SPIO, Kamrup is hereby directed to provide the information to the appellant immediately."

The learned Advocate of the appellant submits orally that he did not receive all sought for informations even after order of the 1^{st} Appellate Authority and as such, preferred 2^{nd} appeal dated 22.07.2019 before the Commission. The SPIO and CO, Hajo Revenue Circle submits orally that sought for informations had already been furnished to the SPIO, o/o the DC, Kamrup. However, copy of the same are available with her and she desires to hand it over to the learned Advocate of the appellant.

In view of the above, the SPIO, O/o the Circle Officer, Hajo Rev. Circle is hereby directed to furnish the sought for informations to the appellant in respect of his RTI application within 7 (seven) days of receipt of this order.

The 2nd appeal petition is hereby disposed of.
