The appellant Sri Joydeep Bhattacharjee is present.

Sri Rafique Ahmed Tapadar, Registrar (Judicial) & PIO, Gauhati High Court, Assam is present. He is assisted by Sri Pradip Sinha, Administrative Officer (Judicial) and Sri Nayan Jyoti Nath, Judicial Assistant. The Registrar (Judicial) and PIO Gauhati High Court has submitted written statement dated 15.12.2020 which is entered into the case record.

The appellant submits orally that the PIO of Gauhati High Court has denied him the sought for informations in contravention of provision of RTI Act, 2005. He also states that he requires the informations for larger public interest but unable to establish his point. He simply reiterates that Justice N. Choudhury was a corrupt person and one case was running in the BCI against him for charge of corruption. He is given opportunity to place a copy of order if the charge of corruption is established by BCI or any other Court. The appellant also informs that the Hon'ble Apex Court has passed order directing the CIC to furnish informations in a similarly situated case. He is directed to furnish a copy of the same on next date of hearing.

Fix next date of hearing on 24.02.2021 at 12:00 PM. This order shall constitute notice for hearing.
