**O R D E R**

The appellant Sri Harinarayan Pathak is present.

The SPIO, o/o the Deputy Commissioner, Dhubri is absent. However, a letter bearing no. DFC.04/2020/RTI/Appeal/60 dated 22.01.2021 of DC-cum-1<sup>st</sup> Appellate Authority, Dhubri is received by the Commission on 01.02.2021 which is entered into the case record.

Seen the case record. The appellant Sri Harinarayan Pathak submitted an application dated 23.10.2019 under the RTI Act, 2005 before the SPIO, o/o the DC, Dhubri seeking certain informations. The SPIO vide his letter no. DFC.03/2019/RTI/355 dated 26.11.2019 furnished some informations received from the Personnel Branch of DC's office, Dhubri. The informations so far furnished by the SPIO did not cover all the informations sought for and as such one 1<sup>st</sup> appeal petition dated 27.01.2020 was submitted before the DC and FAA, Dhubri. By his letter no. DFC.04/2020/RTI/Appeal/38 dated 12.10.2020 the FAA informed the petitioner that the 1<sup>st</sup> appeal has been disposed of vide order memo no. DFC/2020/RTI/Appeal/35(A) dated 07.03.2020 passed on 06.03.2020 after providing all relevant documents.

Seen the order dated 06.03.2020. The FAA in his order stated that it appears that the respondent i.e. SPIO of DC's office, Dhubri furnished the informations on 06.03.2020 to the satisfaction of the appellant which the appellant has denied in today's hearing. He submits orally that he is in receipt of some informations and copies of letters written to the Government of Assam in Revenue & Disaster Management Department in respect of Sri Umesh Ch. Das Lot Mandal(Discharged) but no reply has been furnished by the SPIO of DC's office, Dhubri in respect of Government letter no. RLR.221/2009/36 dated 05.01.2013. **The Commission therefore orders the SPIO, o/o the Deputy Commissioner, Dhubri to furnish the informations whatever action is taken against Government letter no. RLR.221/2009/36 dated 05.01.2013 to the appellant within 7 days of receipt of this order.**

**With the above directions, the 2<sup>nd</sup> appeal dated 30.10.2020 is disposed of.**
