**O R D E R**

The appellant Sri Nityananda Kalita is present.

Sri Rajib Kumar Bania, Asstt. BDO and SPIO, Sipajhar Dev. Block is present.

Seen the case record. The appellant Sri Nityanada Kalita submitted an application dated 02.03.2020 under the RTI Act, 2005 before the Project Director, DRDA, Darrang but he did not get the desired informations in time and as such, he submitted 1<sup>st</sup> appeal dated 28.07.2020 before the PD, DRDA, Darrang. The 1<sup>st</sup> Appellate Authority by his order no. DRDA/MLD/71/Pt-I/2020-21 dated 31.08.2020 directed the SPIO of Sipajhar Dev. Block to take necessary steps to furnish the sought for informations to the appellant with intimation to him. The Secretary, Sipajhar Gaon Panchayat is seen to have furnished certain informations vide his letter dated 03.09.2020. The appellant Sri Nityananda Kalita preferred 2<sup>nd</sup> appeal dated 30.09.2020 before the Commission as the informations provided with are incomplete and not true. Seen the informations submitted by the Secretary, Sipajhar GP. It is observed that some of the informations furnished by him are not true. All the informations sought for are matter of record and there is no bar to furnish the sought for informations. Therefore, **the SPIO and Secretary, Sipajhar GP is directed to furnish appropriate informations against the application of the appellant dated 02.03.2020. The SPIO, Sipajhar Dev. Block is directed to check the informations to be provided with before it is sent to the appellant and to ensure that only appropriate informations are furnished to the appellant. The informations should be provided within 15 days of receipt of this order, free of cost.**

**With the above directions, the 2<sup>nd</sup> appeal dated 30.09.2020 is disposed of.**
