The appellant Smti. Rasiya Begum is present along with her son Mohibuddin Ahmed.

Sri Nityananda Boro, Joint Secretary & SPIO, Secretariat Administration Department is present and submits one letter bearing no. S(N)75/2019/52 dated 05.01.2021 whereby it is informed that written statement had already been submitted during the first day of hearing vide letter no. S(N)75/2019/49 dated 08.12.2020. The Department has informed the petitioner Smti. Rasiya Begum the abstract of the order of Bombay High Court in Dr. Celsa Pinto Vs. Goa State Information Commission (W.P. No. 419 of 2007) RTI Foundation of India, in connection with the queries raised vide letter no. S(N)75/2019/5 dated 25.07.2019.

Seen the case record. The appellant submitted one petition under the RTI Act, 2005 dated 08.07.2019 before the SPIO, o/o the Chief Secretary, Government of Assam. The SPIO, o/o the Chief Secretary, Government of Assam forwarded the said application to the SPIO of Secretariat Administration Department vide letter no. CS/RTI/19/118 dated 10.07.2019. Thereafter, the appellant submitted 1st appeal petition dated 18.09.2019 before the Commissioner & Secretary, Secretariat Administration Department. For non-receipt of the satisfactory informations she preferred 2nd appeal petition dated 25.11.2019 before the Commission.

Seen the RTI petition dated 08.07.2019. The application contains seven numbers of queries instead of seeking informations. For the first five queries the Department is directed to furnish replies appropriately. In respect of query number 6 and 7 the informations sought for are part of the records although it is large in number. Therefore, the appellant is directed to visit the Secretariat Administration Department, inspect the records and take photocopies of informations as per requirement. The first 30 copies of informations the SPIO will provide free of cost, but if the appellant desires to take more copies, then she will have to pay for the same. **The SPIO, Secretariat Administration Department is directed to invite the appellant in a mutually agreed date for inspection of records. He will facilitate the appellant for inspection as well as photocopying of desired informations.**

With the above directions, the 2^{nd} appeal dated 25.11.2019 is disposed of.
