The ASPIO submits one written statement vide letter no. ASC/SV/RTI/2020-21/8861 dated 10.02.2021. The written statement is entered into the case record.

Seen the case record. Dr. Nazrul Kazi submitted one petition under the RTI Act, 2005 dated 24.02.2019 before the Managing Director, Assam Seeds Corporation Ltd. seeking certain informations. He did not receive the desired informations within the stipulated time and thus submitted 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority on 07.02.2020. The FAA vide its order no. ASC/441/RTI/First Appeal/2019-20/4621 dated 24.03.2020 directed the General Manager (F & P) ASC Ltd. to provide necessary informations within 15 days of issuance of the order but the same was not furnished to the appellant and therefore he preferred 2<sup>nd</sup> appeal before the Commission which was received on 23.06.2020. The SPIO, ASC Ltd. through his letter no. ASC/SV/RTI/2020-21/8861 dated 10.02.2021 informs that the sought for informations had been furnished to the appellant on 01.02.2021 and 05.02.2021.

**Since the sought for informations had already been furnished to the appellant, as such, the 2<sup>nd</sup> appeal dated 22.06.2020 is disposed of.**
