# ORDER

04.02.2021

The appellant Sri Dimbeswar Handique is present and submits one written statement.

submits The BEEO. Dhemaji one written statement vide letter BEEO/DMJ/RTI/2019-20/5294 dated 03.02.2021 that she is unable to attend today's hearing due to preoccupied office works.

The appellant submits orally that he is in receipt of other informations against his application dated 15.03.2019 except copy of the appointment letter of Sri Jatin Bora, Head Teacher of Kholihamari L.P. School. Smti. Indira Chamuah, Statistical Assistant office of the BEEO, Dhemaji informed during the hearing on 22.12.2020 that the appointment letter of Sri Jatin Bora, presently Head Teacher of Kholihamari L.P. School was issued by the Director of Elementary Education, Government of Assam only, and as such, her office is not in a position to furnish the copy of the appointment letter of Sri Jatin Bora. Further, she informs that the informations is a third party information and the concerned person Sri Jatin Bora requested the office not to furnish his personal documents to anybody. The appointment letter of a person in a particular post can never be interpreted as personal informations but a matter of record only. Since the BEEO, Dhemaji informs that copy of the appointment letter of Sri Jatin Bora, Head Teacher of Kholihamari L.P. School is not available in her office as such, she will transfer the RTI application dated 15.03.2019 to the Director of Elementary Education, Government of Assam with a request to furnish the copy of appointment letter of Sri Jatin Bora, presently serving as Head Teacher of Kholihamari L.P. School directly to the appellant.

With the above direction, the 2<sup>nd</sup> appeal dated 04.09.2019 is disposed of.
