# ORDER 02.02.2021

The appellant Sri Mokbul Hussain is present.

Sri Muzibuddin Ahmed, Superintendent, FCS & CA branch, DC's office, Dhubri is present on behalf of i/c Deputy Director, FCS & CA, Dhubri. He submitted one written statement bearing no. DSG.5/2018/RTI/PT/218 dated 22.01.2021. It is submitted that the sought for informations had already been furnished to the appellant by the Secretary, Madhusoulamri SS Ltd. by registered post. The appellant informs that he is in receipt of the informations furnished by the Secretary, Madhusoulamri SS Ltd. but his contention is that the first point of his application is not furnished appropriately.

Seen the application dated 01.09.2020 submitted by Sri Mokbul Hussain. The appellant sought for lists of hard copies populationwise for all the dealers under the Madhusoulamri SS Ltd. but this sentence does not carry the meaning what he requires. However, some informations are provided with by the Secretary of the SS Ltd. The appellant is advised to submit another application to the appropriate authority seeking whatever informations he requires. The application should carry full meaning of which information he desires to have. From a plain reading of the letter of the i/c DDS, Dhubri, it is seen that the sought for informations had already been furnished to the appellant.
